

"Nearly ALL students can learn to read words proficiently with sciencebased instruction in foundational reading skills."

From Balanced to Structured Literacy

Balanced Literacy

- readers encouraged to 'predict' unknown words by using context cues such as
 pictures, the preceding sentence, and initial/ final letters to guess what the word might
 be (not processing the letter/ sound relationships)
- Does it look right? Does it sound right? Does it make sense?
- based on opinion or experience and qualitative research based on anecdotal observation/ interviews

Structured Literacy

- a focus on evidence-based 'essential' skills that ALL readers must acquire
- Focuses on connecting speech sounds to print and to the meaning of words (THE READING PATHWAY)
- A direct and systematic approach that progresses from easier to harder skills and is responsive to student needs
- based on decades of evidence-based, scientific research





Re: Special Incidence Portion Claim Funding

I am writing to you on behalf of the members of Bruce-Grey Catholic District School Board's (BGCDSB) Special Education Advisory Committee (SEAC), regarding funding of the Special Incidence Portion (SIP).

We would like to remind you that, in the spring of 2018, the previous government announced an increase to the SIP claim funding of \$11,016.00, bringing that funding amount up to \$38,016.00 per student from the previous funding amount of \$27,000.00. On August 24, 2018, after school board budgets were prepared and approved, the Ministry announced that the previously-announced increase would be clawed back. Currently the funding received from the Ministry is \$28,803.00, bringing the net increase to \$1,803.00 per student.

SEACs across the province were dismayed by the Ministry of Education's decision to claw back that increase, given that the true costs of supporting a student with a SIP claim are significantly higher than the allocated amount. For example, the average cost, including salary and benefits, for an Educational Assistant is \$50,189. A student who requires 2 plus Educational Assistants to support their learning needs would be at a cost of \$100,378 plus. The Ministry of Education's SIP amount covers approximately 28.7 percent of the true cost to support a student with significant learning needs. The BGCDSB covers the remaining 71.3 percent of the cost from other Special Education and operational grants.

In 2017, the Auditor General highlighted that the Ministry of Education's "funding formula uses out-of-date benchmarks and is due for a comprehensive external review." An additional concern for our board is the half/full day allocation of the amount. Given that it already does not come close to covering the cost for students who require these intense supports, we believe a more fair approach is to prorate the amount for a student who is not accessing these supports for a full/half day. Lastly, due to the vast geographical area of our board, large transportation costs are often incurred to transport students with a SIP claim to and from school since regular bussing is not often an option.

Our SEAC is extremely concerned about the direction funding for special education is taking. Inadequate funding of Special Education puts our most vulnerable children at risk by cutting the services that they need to be successful. Our entire system is strained when school boards are required to take revenues from other areas to meet its statutory commitment to children accessing Special Education services. We urge the Minister to evaluate the true costs associated with SIP claims to support our students and increase funding accordingly. We further request, once again, that the Special Education funding model be reviewed and changed to accurately reflect the increasing and more complex needs of students with special needs.

Re: Special Incidence Portion (SIP) Claim Funding

I am writing to you on behalf of the members of the Kawartha Pine Ridge District School Board (KPRDSB) Special Education Advisory Committee (SEAC) to request your consideration of an increase in the maximum per pupil SIP claim amount. Currently, the maximum per pupil funding received from the Ministry of Education is \$28,803.00, which, while very appreciated, amounts to approximately one quarter of the Education Worker salary and benefits costs to support our students with the highest needs. The remaining cost is funded through both the Special Education enveloped grants, as well as through the GSNs.

At KPRDSB, we strive to be very efficient with our resources, yet we continue to spend beyond the Special Education funding envelope by 6.7% in order to ensure that students' programming needs are met. Expenses related to supporting students continue to outpace the revenue provided, which includes the very labour-intensive SIP claims. We do not want to reduce services which some students need to be successful at school; therefore, our entire school system is put under strain because we are required to allocate revenues from other grants to meet our moral and legal obligations to students with special education needs.

We urge you and your team, Minister Lecce, to review the data which is being used to determine Special Education grants in order to assess the true costs of supporting students with special needs. Specifically, we are requesting that the maximum amount of SIP claim funding per pupil be increased to accurately reflect the costs of ensuring these students have full access to education.

We look forward to your response, and we thank you for your consideration.

Re: Special Incident Portion Claim (SIP)

On behalf of the Special Education Advisory Committee (SEAC) for the Durham Catholic District School Board (DCDSB), we are writing in support of York Catholic District School Board Special Education Advisory Committee's recent letter regarding Special Incident Portion Claim Funding.

In the spring of 2018, the previous government announced an increase to the Special Incidence Portion (SIP) claim funding of \$11,016.00, increasing the funding amount up to \$38,016.00 per student from the previous funding amount of \$27,000.00. On August 24, 2018, after school board budgets were prepared and approved, the Ministry announced that the increase would be clawed back to \$28,803.00, bringing the net increase to \$1,518.00 per student.

SEACs across the province were dismayed by the Ministry of Education decision to claw back that increase given that the true cost of supporting a student with a SIP claim are significantly higher than that amount. For example, the average cost, including salary and benefits, for an Educational Assistant is \$60,770. A student who requires 2 plus Educational Assistants to support their learning needs would be a cost of \$115,768.00 plus. The Ministry of Education's SIP amount covers approximately 24.6% of the cost to support a student with significant learning needs. The DCDSB covers the remaining 75.4% of the cost from our Special Education and operational grants.

The normalized budget gap at the DCDSB between Special Education revenues and expenditures for the current years is \$969,870. or 2.8% .Some of the money DCDSB used to fund this gap is the Local Priorities funding (Support for Student Funding), which is not guaranteed to be received annually from the Ministry.

DCDSB SEAC is expressing our concerns that the funding the Ministry of Education provides for SIP is inadequate. The claw back of the SIP increase announced on August 24, 2018, along with the reallocation to the Special Education Per Pupil amount resulted in a net decrease in funding, further increasing the DCDSB deficit. As the Auditor General highlighted in 2018, the Ministry of Education's "funding formula uses

out-of-date benchmarks and is due for a comprehensive external review." DCDSB SEAC is extremely concerned by the direction funding for special education is taking, leaving our most vulnerable children further at risk. Inadequate funding of Special Education at the DCDSB puts our most vulnerable children at risk by cutting the services that they need to be successful. Our entire system is strained when the DCDSB takes revenues from other areas to meet its statutory commitment to children accessing Special Education services.

We request the Minister to evaluate the true costs associated with SIP claims to support our students and increase funding accordingly. We further request, that the Special Education funding model be reviewed and changed to accurately reflect the increasing and more complex needs of students with special needs.

Thank you for your letter regarding Special Incident Portion (SIP) funding. I appreciate the opportunity to respond.

The government is supporting each and every school board in the province to ensure our students, including students with special education needs, and educators have the resources available for a successful year.

Special Education Grant (SEG) funding is projected to increase to over \$3.25 billion for the 2022-23 school year. The highest amount ever provided in Special Education Grant (SEG) funding, this represents an increase of approximately \$93 million, or 2.9 per percent, over 2021-22 Special Education Grant (SEG) funding. The maximum SIP funding amount per eligible claim has incrementally increased year over year. This, as you have pointed out, has culminated to with a maximum of \$28,803 per SIP claim for the current school year, with an overall projected total SIP funding amount of \$142 million for 2022-23.

In addition to Special Education Grant (SEG) funding, school boards can use other Grants for Student Needs (GSN) and Priorities and Partnerships Fund (PPF) funding to meet their responsibility to support students with special education needs.

We continue to provide funding outside of the Grants for Student Needs (GSN) through Priorities and Partnership Funding (PPF) for a variety of time-limited, high-impact initiatives that directly support students in the classroom. In 2022-23, we are providing school boards with \$40.8 million in Priorities and Partnerships Funding (PPF) to

support programs that will benefit students with special education needs, and will also support student potential in Ontario; and we are providing an additional \$5.85 million in special education Third-Party investments.

I would like to take this opportunity to thank you and the Special Education Advisory Committee (SEAC) for your commitment to the needs of students. I would also like to thank you for reaching out to the Ministry of Education, and I trust the above information will be useful to you.

Professional Development Day - June 12, 2023

Learning during the PD Day for Educational Assistants was led by Dr. Anthony Cammilleri, a Board Certified and Licensed Behaviour Analyst and Special Education Administrator. Dr. Cammilleri is a Senior Consultant and Director of Education at First Things First (FTF) Behavioral Consulting. The session for EAs focused on providing an overview of the Universal Protocol (UP) and Skill-Based Treatment (SBT) framework for students who exhibit problem behaviour. There were also several opportunities for educators to ask questions to gain helpful tips for program support and skill-based learning goal tracking, and to learn from Dr. Cammilleri's compassionate, value-based examples of strategies to promote positive student-educator relationships.

On Tuesday, June 13, Dr. Cammilleri met with KCDSB principals to provide school leaders with a similar overview of the UP and SBT practices that he shared with the EA group, tailored to the perspective of school administrators (e.g. considerations for shared policy development, staff training, instructional design, data collection, etc.).

Dr. Cammilleri was also able to take a tour St. John Paul II school to meet educators who have already begun implementing UP and Today's ABA SBT practices.

Plans are also underway for the 2023-2024 KCDSB Professional Activity (PA or 'PD') days with the school year beginning with two PA days (Aug 28 & 29) that focus on Ministry and board-determined topics that prepare staff to support students for a successful return to school and learning.
